Reference is invited to CBIC Circular No.11/2025-Customs dated 03.04.2025, CBIC Notification No. 21/2025-Customs (N.T.) dated 03.04.2025, ICES Advisories 18/2025 dtd 07.04.2025 and 16/2025 dated 25.03.2025 vide which it was informed that the functionality to amend the SB post EGM has been developed and the process to amend the SB was prescribed in the above said ICES Advisories.

2. In this regard, an MIS report has been developed in COM role (COM Role--> Exports--> Misc Reports--> Post EGM Amendment) for monitoring the cases where Post EGM Amendment has been done. User needs to provide the amendment date period for which report needs to be generated. After entering the period, all the SB details approved for Post EGM Amendment under that period will be displayed.

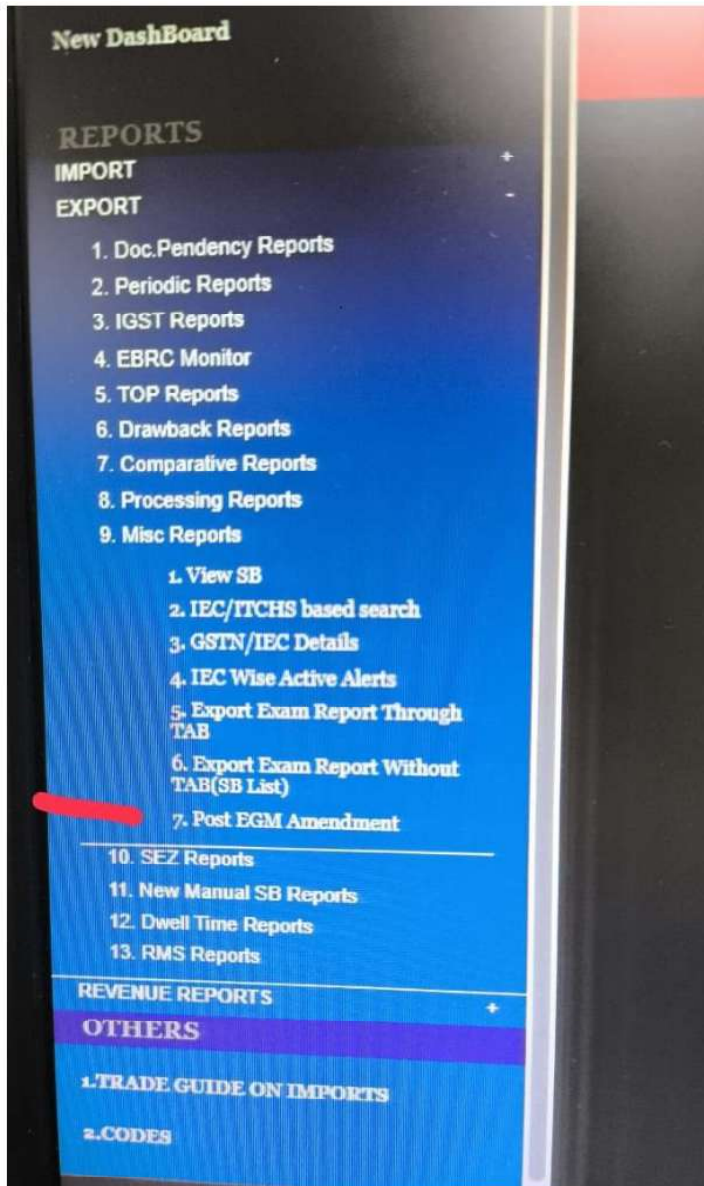
